Before you invest in any fund, you should consider how it would work with your other investments and your tolerance for risk.

Subject to securityholder approval, the Fund's investment objective will be changed and the Fund will acquire assets from three Bridgehouse Funds in a material merger, effective January 27, 2023. If the investment objective is approved, the Fund will be renamed "T. Rowe Price Global Allocation Fund", the portfolio sub-advisor will be changed to T. Rowe Price (Canada), Inc., and the Fund's investment strategies will be modified.

High net worth pricing is available for eligible investors who meet the minimum Fund account balance. Please see the simplified prospectus of the Fund for more detail, including how the accounts of an investor can qualify.

What does the fund invest in?

The investment objective of the Fund is to achieve a combination of long-term capital appreciation and income by investing primarily in a diverse mix of other mutual funds and exchange traded funds that invest in Canadian and global fixed-income and equity securities.

Morningstar uses a disciplined process to actively manage the funds asset mix and investments with a range of exposure of from 25% to 55% in defensive assets such as fixed income and cash and from 45% to 75% exposure to growth assets such as equities.

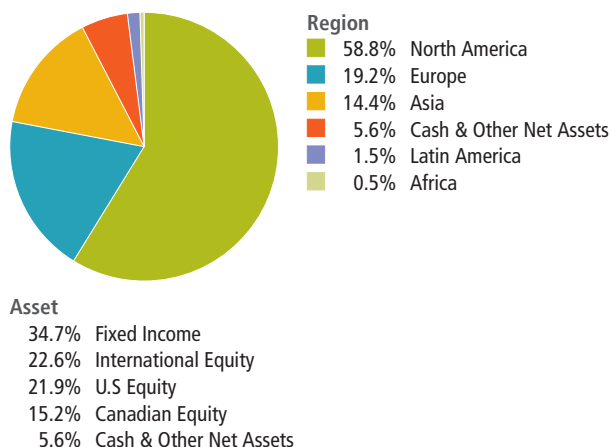

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Bridgehouse has rated the volatility of this Fund as **Low to Medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

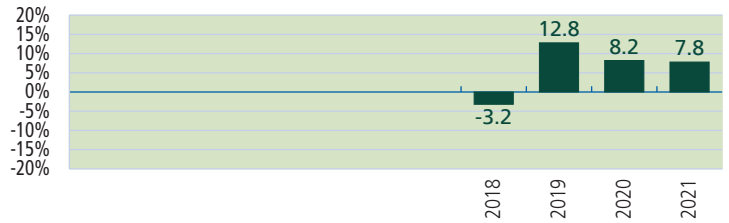
Like most mutual funds, this Fund does not have any guarantees. You may not get back the amount of money you invest.

How has the fund performed?

This section tells you how Series F units of the Fund have performed over the past 4 years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

Year-by-year returns

The bar chart shows the Fund's Series F units annual performance for each of the years shown. The Fund dropped in value once in 4 years. The range of returns and change from year to year can help you to assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series F units of the Fund in a 3-month period over the past 4 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

If you invested \$1,000 in the Series F units of this Fund on the day the Series was established it would be worth \$1,169 as of October 31, 2022. This represents an annual compound rate of return of +2.9%.

Who is this fund for?

- This Fund is suitable for investors who are long-term investors and who wish to add the income potential and appreciation potential of fixed income and equity mutual funds and exchange traded funds to their portfolio. This Fund is not suitable as a short term investment or for an investor who cannot tolerate a low to medium degree of volatility.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, any fund distributions are included in your taxable income, whether you receive them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series F units of the Fund. The fees and expenses - including any commissions - can vary among each series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

This Series of units does not have a sales charge option.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns. As of June 30, 2022, the Fund's expenses were 1.23% of its value. This equals \$12 for every \$1,000 invested.

	Annual rate (as a % of the fund's value)
Management expense ratio (MER) This is the total of the Fund's management fee and operating expenses as at June 30, 2022. Bridgehouse Asset Managers waived some of the Fund's expenses. If we had not done so, the MER would have been higher.	1.17%
Trading expense ratio (TER) These are the Fund's trading costs.	0.06%

More about the trailing commission

There are no trailing commissions paid in respect of this Series of units.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What you pay
Service Fee	You pay your representative directly a fee. Units in this series are purchased under fee-for-service accounts.
Asset-based fee	Investors generally pay their representative's firm an asset-based fee that is negotiated with and charged by their representative's firm.
NSF cheque fee	A fee of \$25 may be charged on NSF cheques.
Short-term trading fee	Bridgehouse reserves the right to charge a short-term trading fee of up to 5% of the NAV of any units you sell or switch within 30 days of purchase in addition to any switch or redemption fees that may apply in order to deter inappropriate and excessive short-term trading that is harmful to the Fund.
Switch Fees	A maximum of 2% of the amount being switched may be charged and paid to your representative's firm to provide compensation for the time, advice and processing costs involved in a switch. All switch fees are negotiable with your representative.
Wire transfer fee	A fee of \$25 may be charged if you request a wire transfer.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
